NOTICE OF DRAFT VARIATION OF THE MEATH COUNTY DEVELOPMENT PLAN 2013-2019

Notice is hereby given pursuant to Section 13 of the Planning and Development Acts 2000-2017 that Meath County Council proposes to make a variation (Variation No. 4) to the Meath County Development Plan 2013 - 2019. The proposed variation provides for the inclusion of objectives for the regeneration and renewal of land and the active land management of vacant sites within the Settlement/Core Strategy of the County Development Plan.

Reason: To comply with the requirements of, and to give effect to the Vacant Sites Register in accordance with the Urban Regeneration and Housing Act 2015.
